## 1.) Global Gallery

In a highly interactive session, participants learn about 25 different projects from around the world that showcase innovative approaches to and successful examples of multi-faith collaboration for peace. Participants review and discuss best practices while at the same time forging bonds with sister projects and potential future cooperation partners.
